

All will be asked to abide by our 'Code of Ethics', and of course any conditions set down by mining companies and landowners.

# **ORIGINS and HISTORY OF A.F.L.A.C.A.**

The 'Australian Federation of Lapidary & Allied Crafts Association' probably had its beginnings on 25th July 1964, when more than 40 people representing 10 New South Wales Lapidary groups attended a meeting called by Mr. Bert Kidd of the 'Western Suburbs Lapidary Club'. Purpose of the meeting was to discuss the pros and cons of forming a Federation of Lapidary Clubs.

Resulting from that meeting an advisory committee was formed. After a further meeting of this Committee, a questionnaire was sent to all clubs, seeking their views on forming a Federation.

On 24th October 1964, 'The Australian Association of Lapidary Clubs' was formed at a meeting held in the Gas Company Auditorium, Burwood, NSW. 9 Clubs were founding members – 7 from NSW, and 1 each from Victoria and Queensland, but it appears that this Association did not prosper.

Probably the next positive step towards a National body was a meeting in early 1968 between the then 'NSW GEMBOREE Committee' and the 'Victorian Gem Clubs Committee'. At this meeting, held in Sydney, it was agreed to a request from Victoria to stage the GEMBOREE in 1969. This was the start of the GEMBOREE being staged in all States, which in turn, led to greater contact between Clubs and Lapidaries Australia wide and the possibility of staging a GEMBOREE led to the formation of Associations in 3 States.

During the 1974 GEMBOREE at Nambour, representatives of all States agreed in principle to the idea of forming a National Body. Tom Jenkins and Tony Annear, President and Secretary respectively of the GEMBOREE 1975 Committee, were charged with the job of 'undertaking the necessary liaison with all State bodies towards the planning of a meeting aimed at the formation of a National Body'.

Objective was to form a National Steering Committee at GEMBOREE 1975. This was duly done, with three representatives from each State. Tom Jenkins was elected Chairman and Tony Annear Secretary.


The task of the Steering Committee was to review the following matters and place recommendations to a 'formation meeting' at GEMBOREE 1976: (1) Confirm desirability of forming National Body: (2) Recommend a title for the Body: (3) Draw up a Constitution, which includes defining function of the Body: (4) Decide on membership/affiliation fees: (5) Design a National Emblem: (6) Decide State representation on the Committee.

The following year was a vast interchange of correspondence and a number of interstate meetings, leading up to the meeting of the Gunnedah GEMBOREE. At this meeting, the 'Australian Federation of Lapidary & Allied Crafts Association' (AFLACA) was formed. A few months later, the emblem as we now know it was adopted.

The objectives of AFLACA can best be summed up as:

"To promote popular interest and education in Lapidary and related Crafts; to sponsor and provide means of co-ordinating the efforts of all groups interested therein; to encourage the development and formation of Clubs through State Associations, and by such means, strive towards greater national goodwill and fellowship"

Two major achievements have been the introduction and adoption of a National standard for Competitions and Judging and the adoption of a National calendar for staging the GEMBOREE.

# GMCASA – what is it?

The acronym GMCASA stands for the 'Gem & Mineral Clubs Association of South Australia', an organization consisting of all the Gem & Mineral Clubs and Detecting Clubs in South Australia.



In 1972 six clubs – AGMC, NDGC, WREI (now DRCI), SR and YPGMC, and from the border in Victoria, Sunraysia, got together and staged GEMBOREE 1972 at Tanunda.

At the close of that GEMBOREE these six clubs decided to form a State Association – namely GMCASA, which has expanded as more Gem & Mineral Clubs and now Detecting Clubs have been formed in South Australia. GMCASA now has a membership of **18 clubs**.

The purpose of the Association is to foster the Lapidary and Allied Arts and Crafts and Sciences; to get all Clubs under a common 'Code of Ethics' to protect flora, fauna, native arts and natural monuments. Another function is to watch and monitor legislation as it relates to clubs and to maintain good public relationships with State and local authorities, landowners and the general public.

Another important factor is the standardization of competition rules and judging throughout Australia. This means that no matter where or at what level of competition one is at, the rules will be exactly the same and judging will be standard.

GMCASA is a Foundation Member of AFLACA (the Australian Federation of Lapidary and Allied Crafts Association) and through that organization maintains full contact and liaison with all interstate and national affiliated and/or associated organizations. GMCASA, through a subcommittee, coordinates the Clubs efforts in staging the National Gem & Mineral Show – GEMBOREE, so we hope that you will enjoy 2013.

# **GEMBOREE PRINCESS TIARA**

In 1979 Miss Karen Hales, the daughter of the President of the Enfield District Lapidary Club (as this club was then known) was crowned GEMBOREE Princess using a tiara borrowed for the occasion. Three years later at the Glen Innes GEMBOREE another tiara was borrowed to crown the GEMBOREE Princess.

In 1982 the President called a meeting to discuss this problem and as a result decided that the Gem Clubs of Australia should have their own Tiara and as a result of that meeting we notified AFLACA (Australian Federation of Lapidary & Allied Crafts Association) that we intended to make a Tiara to be used to crown the GEMBOREE Princess at future GEMBOREES and that it would be ready for use at the Broken Hill GEMBOREE only nine months away.

The task was a large one, but with most members becoming involved the enthusiasm grew and the job was completed within the time available.

The 'Enfield Tiara' as it is now known is made of sterling silver and contains 65 faceted gemstones together with five nephrite jade pillars. It is in fact valued in excess of \$5000.

The largest individual job was of course the sterling silver frame. This required dozens of drawings as it had to be capable of fitting heads of all sizes. Then there were the settings for the 65 faceted stones. These were all individually hand made to suit the various sized gemstones. The frame had to be strong enough to withstand handling but be light enough to wear.

The gemstones comprise 60 faceted topaz, all about one carat each collected by club members on holiday in Queensland, then cut and polished. Rare black jade from Cowell in South Australia was used to form the five pillars; these are topped by five larger faceted gemstones, two of golden citrine, two of synthetic aquamarine and one large pink cubic zirconia weighing 16.5 carats.

One club member who felt he was left out as he was unable to work silver or cut gemstones at that time, hand crafted a magnificent blackwood carrying case to ensure that the Tiara can be safely transported from State to State for it's annual event – the crowning of the Senior GEMBOREE Princess.

# Mineral Resources Division Resources and Energy Group, DMITRE

The Mineral Resources Division (MRD) is part of the Resources and Energy Group within the South Australian Department for Manufacturing, Innovation, Trade, Resources and Energy (DMITRE). MRD is responsible for facilitating



Department for Manufacturing, Innovation, Trade, Resources and Energy

mineral exploration and development, and is focused on increasing the prosperity of South Australians by ensuring responsible development of South Australia's mineral resources, within a sustainable framework. It provides geoscientific and specialist services as part of a process to acquire and update geological, geophysical and engineering data. MRD is also responsible for industry regulation, legislative development and review, policy development and provision of advice. The division is organised under leadership in the areas of Mineral Tenements and Exploration Regulation; Geological Survey of South Australia; Mining Regulation; Mining Projects Facilitation; Resource Land Access Strategy; Resource Information and *PACE 2020*.

A critical role is to promote the state's mineral potential. The MRD purpose is A better South Australia through sustainable development of our mineral and energy resources' and the division's structure is closely aligned to achieving one of the key visions of South Australia's Strategic Plan (SASP) to achieve 'A strong, sustainable economy that builds on our strengths'. Specific minerals and energy targets are: 41 Minerals exploration - exploration expenditure in South Australia to be maintained in excess of \$200 million per annum until 2015; and 42 Minerals production and processing - increase the value of minerals production and processing to \$10 billion by 2020. In addition, the minerals industry is a major contributor to Target 37 Total exports - contribute to increasing the value of South Australia's export income to \$25 billion by 2020. South Australia continues to be very successful in this regard with mineral exploration, production and exports all achieving year-on-year increases of around 50% for 2010-11. Minerals production and processing (Target 42) reached \$5.9 billion in 2010-11 and this high achievement places the state in an excellent position to achieve the \$10 billion target by 2020. In addition, mineral exploration expenditure of \$254.7 million achieved in 2010-11 is already in excess of Target 41. Resource royalty receipts exceeded \$119.4 million in 2010-11.

Helping to achieve these SASP targets is the South Australian Government's Plan for Accelerating Exploration (*PACE*) which is recognised around the world and throughout Australia as one of the most successful government initiatives in stimulating new mineral discoveries and in attracting and securing major levels of mineral exploration investment. In 2010 the government announced a \$10.2m expansion of the initiative – known as *PACE 2020* – which leverages this phenomenal success and goes further. *PACE 2020* focuses on new areas and methodologies for exploration as well as developing best practice mine development processes which enable mining projects to be approved faster, with less red-tape. *PACE 2020* also builds on our world-class service to the minerals and energy industry by providing an even greater range of online geological and geophysical information to support the exploration.

This is used to assist exploration, sustainable development and sound land-use planning.

The Resource Land Access Strategy Branch deals with land access issues which have for many years been the prime concern of the resources sector and are critical factors in mining investment decision making. Together with the Mining Projects Facilitation Branch, important responsibilities include legislation review, evaluating and improving government processes, policies and legislation, administering the various mining acts, agreements and regulations and the award and management of all mineral tenements, as well as monitoring and facilitating emerging mineral developments.

The Mineral Tenements and Exploration Regulation Branch and Mining Regulation Branch regulate mineral exploration and the mining industry in South Australia in accordance with legislative requirements and with minimal impact on the community and the environment. Activities include mining operations compliance inspections, administering and regulating opal mining, administering the Extractive Areas Rehabilitation Fund, and approval of mining and rehabilitation programs and schemes.

The Resource Information Branch is the Resources and Energy Group's promotional arm and promotes the state's prospectivity and competitive advantages, nationally and internationally. Its activities include communications, event management, publications, product development, education and training, mineral industry liaison, mineral economics, market research, and website development and management.

#### PART 2. GENERAL CONDITIONS OF ENTRY

- 2.1 The OFFICIAL ENTRY FORM or copy thereof must be used.
- 2.2 All Entry fees MUST accompany the OFFICIAL ENTRY FORM, as follows: Entry fees 50c per entry up to 10 entries. Every entry after will be free. NO MORE THAN TWO (2) ENTRIES PER PERSON PER SECTION WILL BE ALLOWED. Except for showcases sections where only 1 entry per person is allowed. Medals will be awarded to 1st, 2nd and 3rd placed entries and/or Highly Commended. Where there are few entries in a Novice or Intermediate section, awards MAY be nominated as 'special awards' and will not affect Entrants eligibility in future competitions. Only 1 entry per section will be eligible for a medal.

- 2.3 Whilst every care will be taken, the GEMBOREE SA Committee will not accept any responsibility for any loss or damage of Competitive or Non Competitive entries that may occur in transit or whilst in the possession of the GEMBOREE SA Committee.
- 2.4 The GEMBOREE SA Committee regrets it is unable to carry insurance cover on entries/exhibits whilst in their possession. We strongly advise competitors and exhibitors to arrange their own insurance cover.
- 2.5 A self-addressed stamped envelope must be included for acknowledgment of entry forms.
- Overseas entrants are requested to use an International Reply Coupon (in lieu of 2.5 above).
- 2.7 Cheques and other monetary instruments are to be made payable to 'GEMBOREE 2013 Committee'. Payment from Overseas is ONLY to be made via bank cheque (in Australian currency) drawn on any Australian bank.
- 2.8 Overseas entrants are advised to clearly label their postal packages 'Lapidary Competition Entries—to be returned'. It is also advisable to include a copy of the entry form in the package. Experience has shown that this minimizes possible Customs queries both in Australia and the country of origin.
- 2.9 The GEMBOREE SA Committee reserves the right to transfer any entry into its correct section, if in their opinion the entry has been entered into the wrong section.
- 2.10 JUDGING SHEETS will be available for collection on presentation of the official receipt, between 4 pm and 6 pm on Saturday 30th March. Judging sheets not collected then will be returned with the actual entries.
- 2.11 COMPETITOR DIVISION eligibility will be in accordance with the provisions of para. B4. of the manual. It is the responsibility of the Competitor to nominate entries in accordance with his/her Division Status. All Nomination Forms will be checked against the current AFLACA COMPETITOR DIVISION STATUS LIST. Where possible incorrect nominations may be transferred to their correct sections. All Overseas Competitors, other than Juniors, will be deemed as Open Division.
