- 1. I will abide by the following terms and conditions to trade externally at GEMBOREE 2026 hosted by the Queensland Gem Clubs Association Inc.
- 2. I will trade only within the times and areas allocated to me by organisers.
- 3. I will trade in a respectful manner at all times and follow instructions from the organisers.
- 4. Application to trade externally does not entitle me to trade except upon acceptance by the organisers and receipt of the permit to trade.
- 5. I agree to pay the appropriate registration fee as a participant of GEMBOREE 2026 and to pay the required External Trading fees.
- 6. Goods for sale are to be limited to those directly related to Lapidary and Jewellery crafts.
- 7. All synthetic material is to be clearly marked as *synthetic* or *manmade*.
- 8. <u>I am solely responsible for items you sell</u>. Wrong or misleading information is not permitted. All goods must be correctly identified and clearly marked with the retail price.
- 9. Should I contravene any part of this contract, I agree to vacate the event and forfeit all monies paid.
- 10. I agree to produce evidence of Public Risk Insurance for a minimum amount of \$20,000,000 on arrival at the entrance gate.
- 11. Application forms are available from the organizing committee and form part of this contract i.e. a signed application form indicates full acceptance of these terms and conditions by myself and/or any other person authorized by me.
- 12. All power leads used to connect to Showgrounds power must in accordance with State regulations and have an up-to-date tag. A person may be available to check and tag leads for a fee if required.
